## 1. CLERKS REPORT.

(a) Thanks to Cllr Tucker for arranging this first meeting. Due to its success it is proposed to hold future Parish Council meetings in this way.

## 2. CORRESPONDENCE

- (a) SELBY PLAN. New information and drawings have been received from SDC on various sites which have been submitted by landowners. The ones that concern our Parish are Bolton Percy four sites and Colton one. Cllr Musgrave gave a very interesting update on the production of the Selby Plan in general and these sites and the outcome was that the Parish Council in the first place can give their comments on each particular site ie liable to flooding, inadequate access etc which could help SDC in the future when and if planning permission is sort. It seems there are no plans for any development in the forthcoming year. The general public will be given the chance to express their thoughts from January to March 2021 when more information will be made public. It was decided that the Parish Council will make residents aware when this is going to public consultation.
  - Cllr Musgrave also said that the Plan may be overtaken by the formation of the new unitary authority which is to replace the District Councils in North Yorkshire. The two options for this are to be submitted by the District & County Councils to the Government before 9<sup>th</sup> December.
- (b) VILLAGE PUMP VOLUNTEERS. It was decided with the departure from the village of Cllr Isherwood, the Clerk was requested to update the protocol of the village pump. This would be helpful to the remaining residents of Vine Cottages as over time personnel from Environment Agency have changed. Clerk to Action.
- (c) DEFIB UNIT COLTON. Cllr Robinson is again in contact with Northern Powergrid to get electricity connected to Colton telephone kiosk so this unit can be fitted asap.
- (d) DEFIB UNIT BOLTON PERCY. Two new volunteers have come forward to help with the checking on a weekly basis this defib unit to make sure it is always ready for use in an emergency.
- (e) PUBLIC FOOTPATH EX GAME FARM. It has been confirmed this footpath has been fully reinstated after it was ploughed up earlier this year. It was asked if some of the stiles and overgrown hedges could be cut back. Clerk to contact landowners.
- (f) RESIGNATION OF COUNCILLOR. Cllr Isherwood has tendered his resignation to the Clerk as he has left the village. The Chairman has been in touch to offer his thanks on behalf of all councillors for all his hard work carried out by Richard over the years. A notice has been put on the Notice Board to advertise the vacancy.

(a) Land adjacent St Paul Church, Colton – 2020/0061/FUL

Proposed erection of new dwelling house with carport/stores and outbuilding plus outbuilding and associated landscaping including new access to Highway.

The Parish Council have submitted their objections to this application and feel due to its size and position of the plot it does not fit in with all other properties in Colton.
