1. CLERKS REPORT - ACTION FROM LAST MEETING

- a) Pumping Station Colton Update. Cllr Robertson confirmed planning permission is still awaited
- b) Defibrillator, Colton Update. Cllr Robinson has finally succeeded in getting an Estimated Annual Consumption Certificate from Northern Powergrid for supply electricity to the telephone box. This allowed him to get a quotation for the power from a company. [This will be Eon at £16.55/per year inc VAT. The Parish Council have received a certificate from Northern Powergrid confirming this. Cllr Robinson is now making arrangements for the power to be re-energized. The defibrillator will be fitted as soon after this work is carried out. The phone box will remain as a book exchange with new shelves fitted around the defib unit.
 - Thanks must go to Cllr Robinson for his diligence in bringing this to a final and successful conclusion
- c) Yorkshire Water Bumblebee Cottage Manhole Bolton Percy. Cllr Nicholls has investigated the problem with this manhole having sandbags put on top. The conclusion of this is that the manhole is on private property therefore the Parish Council cannot get involved and Yorkshire Water are aware of the problem and will contact the owner of the property.
- d) Footpath Signage Bolton Percy. Clerk has spoken with Nun Appleton Estate who have agreed to re-instate the missing signs.
- e) Requested site meeting regarding footpaths Bolton Percy Cricket Field and Pump Alley. Clerk to arrange a site meeting with NYCC.

2. CORRESPONDENCE

- a) New Laptop for Parish Council. The Parish Council all agreed to purchase this item from the Council accounts to replace the old one which was out of date. Total cost ££574.62 + VAT
- b) Parish Council Insurance Renewal. Councillors agreed to renew with Zurich Insurance which has increased by £7.72 from 2020.
