Clerk updated the PC on current finances up to the end of 31.12.24. It was agreed to move £5,000 pounds into the savings account from the current account.

Cllrs decided it is important to spend the available funds with the needs of the Parish in mind, therefore, Cllrs considered funding small electronic speed signs and clerk will a. contact highways to find out what permissions are now required. b. Obtain quotes for signage.

9. PARISHIONERS ITEMS FOR DISUSSION/ANY OTHER BUSINESS

i. Email from parishioner concerned about flooding at the Ramparts and the flood gates not working effectively.

Clerk had forwarded email to all Cllrs and Cllr Nicholls in his role as Flood Warden has sent a reply via the clerk to parishioner on behalf of the PC to confirm the flood gate is working as it should. The River Wharf is dropping releasing water back through Nun Appleton flood gate plus the Environment Agency (EA) has a pump at this location to assist. This will help move water from the Foss quickly through the rampart with the weight balance push as much out as possible. The EA are aware and will do what is necessary. The Parish Council are working closely with the EA to prevent as much disruption to possible property flooding plus road flooding

ii. Email from parishioner concerned about frequency of Power Outages in the local area.

Cllrs reported that outages have been a problem in the area. Clerk will contact Northern Powergrid to raise the concerns of PC and parishioners and to make sure all "complaints" were logged. Clerk will also start to keep a log of all power outages for BP and For Colton/Steeton and the length of time the electricity has been off. Cllrs had viewed the Powergrid website and noticed that not all outages had been logged for the area. Therefore, the PC would urge local residents to contact Northern Powergrid should there be an outage. This way the energy suppliers are more likely to deal with the problem.
