- 6. CLERK'S REPORT: ACTIONS TAKEN FROM LAST MEETING:
- a. Update on speed control signage (VAS) for Colton Village

Clerk distributed the survey report from the Speed Survey completed by NYC. Recommendations from NYC stated that a VAS sign was not required at this stage. Cllrs asked Clerk to contact Mr Griffiths to ask for further information on the data as the survey was vague and no context had been applied or explanation on how to read the data.

b. Update on new pump for Pump Alley and the surrounding area.

Cllr Nicholls has provided two detailed quotes, which were distributed. A third quote is to be provided before a decision will be made.

c. Update on Police Surgery in the villages (from previous meeting)

There was a good attendance for the Community Meeting led by Hannah Price PSCO and Annie Newbould PSCO from the Selby Neighbourhood Policing Team based at Eggborough Police Station. 20 members of the public attended, representing BP, Colton and Acaster Selby. The meeting was a question-and-answer forum, areas covered; safety and security of property and possessions; fraud and cyber-fraud; crime in the Selby area. Feedback was positive from all concerned. Clerk to contact NY Police to thank PSCOs Price and Newbould for their advice on behalf of the residents.

d. Update on LEA

The LEA working party are meeting on the 10th June to formulate a letter to the CAA regarding the post-implementation review for an Airspace Change Proposal ACP-2016-13. Comments are invited from stakeholders by 25th June 2025. Clerk has emailed all neighbouring PCs inviting local Cllrs/or representatives to attend including District Cllr. Lee.
